INVESTMENT OBJECTIVES

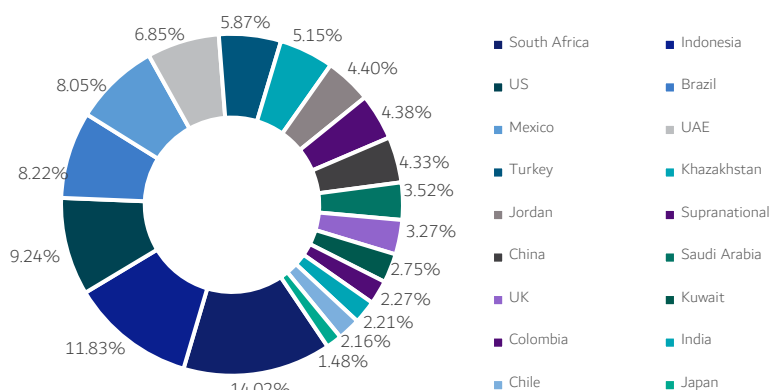

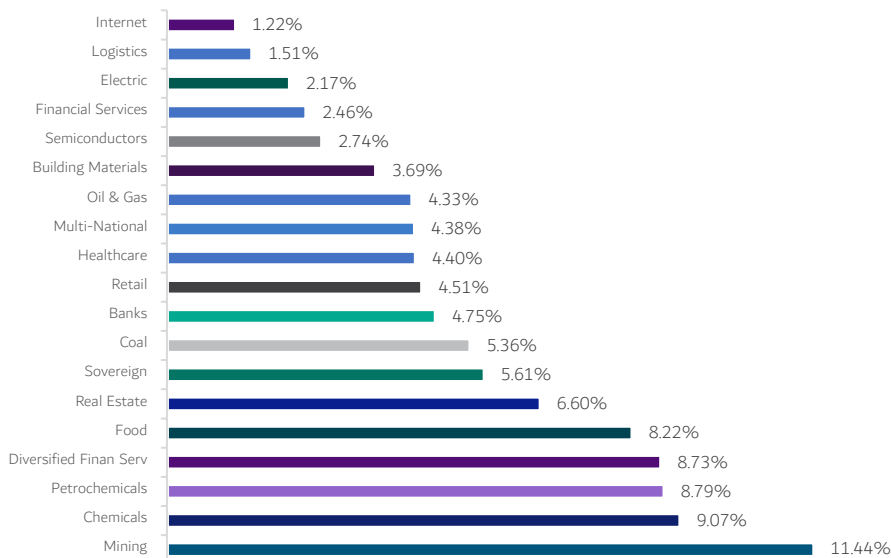
