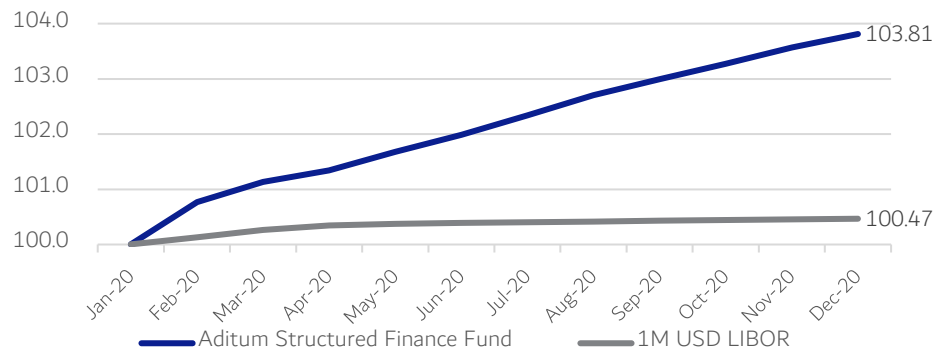

## INVESTMENT OBJECTIVES:

The Aditum Structured Finance Fund will seek to achieve attractive risk-adjusted returns with downside protection in a diversified portfolio of private debt opportunities. The Fund expects to generate low volatility returns which are uncorrelated to traditional asset classes, and which generally exceed other investments of a similar duration. The Fund invests in, but is not limited to, trade finance, structured trade, export/import finance, supply chain finance, inventory finance, borrowing base finance, receivable finance, asset-based finance, bridge finance, expansion finance and project-based finance opportunities, across the supply chain located primarily in, or having exposure to, global emerging markets.

## INVESTMENT STRATEGY:

### Growing Asset Class

Since banks withdrew from lending over a decade ago, structured finance funding has grown significantly and gained attention from investors as most debt opportunities have strong downside protection, making it an appealing alternative strategy.

### Fundamental to the Economy

Structured finance is essential to international economic growth and development, it helps boost international investment, creates jobs and capital inflows where a country has a comparative advantage and enables countries to earn foreign exchange.

### Risk Mitigation

Historically low risk asset class with underlying assets transactionally secured and enhanced through risk mitigating credit techniques, such as insurance.

### Investment Diversification

The Fund's investments will consist primarily of loans, which act as a natural hedge to other traditional asset classes, and which are backed by real assets. Returns lack the volatility of other asset classes and the risk of default is reduced with credit and collateral enhancement.

## INVESTMENT BENEFITS:


- Uncorrelated to traditional asset classes with targeted lower volatility
- Consistent annuity like returns in different market conditions offering increased portfolio diversification
- Lack of sensitivity to long-term interest rates due to shorter terms and primarily floating-rate interest
- Investments are relatively short term and self liquidating to mitigate the risk of capital loss
- Underlying typically secured and backed by real assets in the real economy which are globally diversified
- An asset class with historical low default rates of underlying investments
- Fully scalable investment strategy with increasing number of opportunities due to worsening trade finance gap
