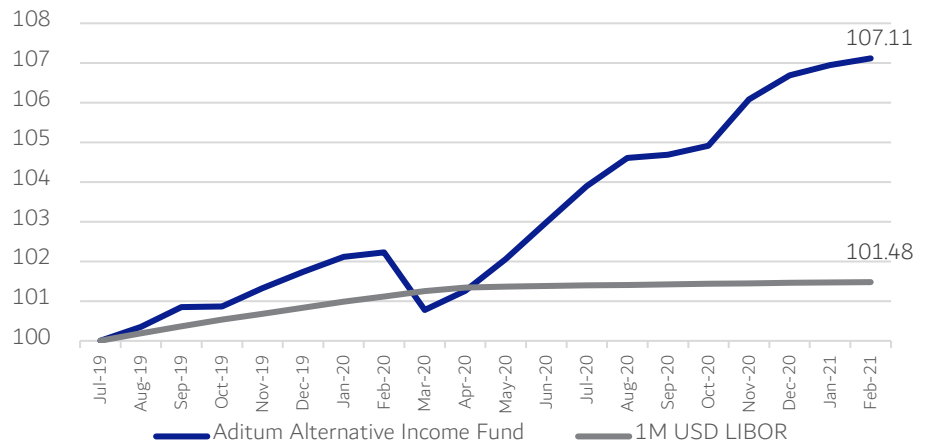
ABOUT ADITUM

ADITUM ALTERNATIVE INCOME FUND COMMENTARY

February was a tumultuous month for government bond markets as we saw a dramatic repricing in both the middle and the long-end of the curve and defensive assets sold off aggressively. By comparison, risk assets were largely unaffected and high yield and EM debt markets continued to perform well, especially on a relative basis.

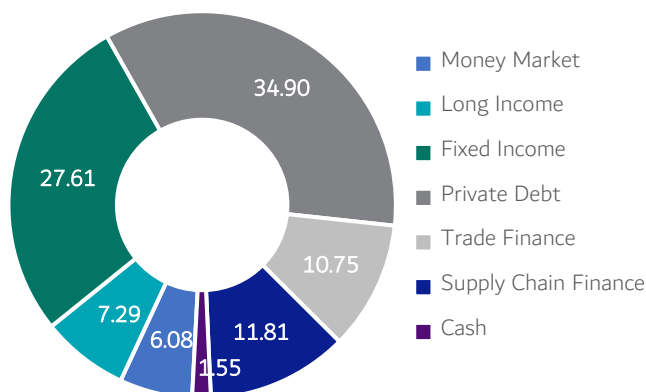
The fund emerged from the period with a slight gain but this muted performance masked some large variance across underlying holdings. The short duration positions in EM and HY were strong and our positions in private debt served us well as did our unhedged GBP positions. This said, our concerns over the seemingly stretched valuations in certain parts of the market, and a consequent move into more defensive flexible holdings, detracted significantly from performance as we saw the most conservative funds fall more than 2% over the month.

Given the wider economic pressures, it seems inconceivable that policymakers (while currently largely silent on the sharp movement in yields) will allow this to stifle nascent growth and the prospect of a smooth re-opening of economies later in the year. While yield curve control may not be an explicit target, some form of intervention, or talk of intervention, would likely lead to a flattening of the curve. We continue to watch this closely and will use any further sharp movements as an opportunity to pick up defensive assets at attractive prices.

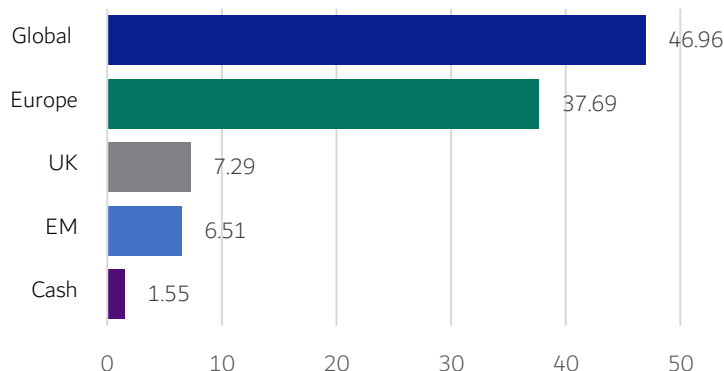
