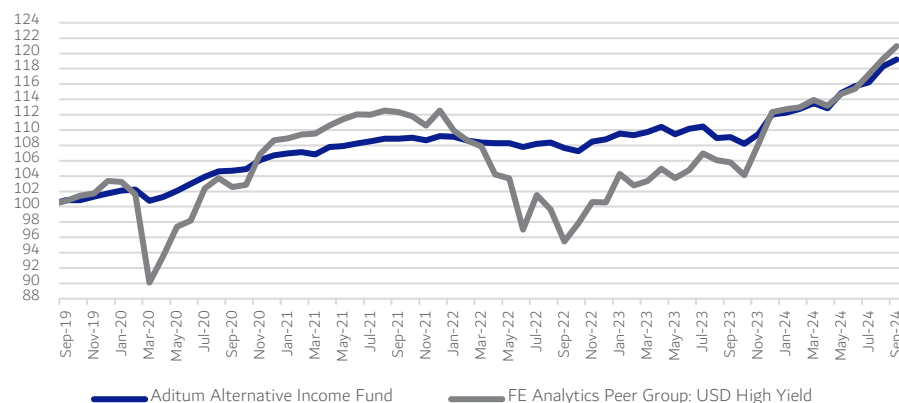

INVESTMENT OBJECTIVES:

The Aditum Alternative Income Fund aims to deliver attractive risk-adjusted returns by investing in assets, predominantly collective investment schemes, that are expected to generate income and capital growth over a 3yr period. It will seek to deliver risk-adjusted returns versus traditional fixed income funds with similar credit qualities and durations.

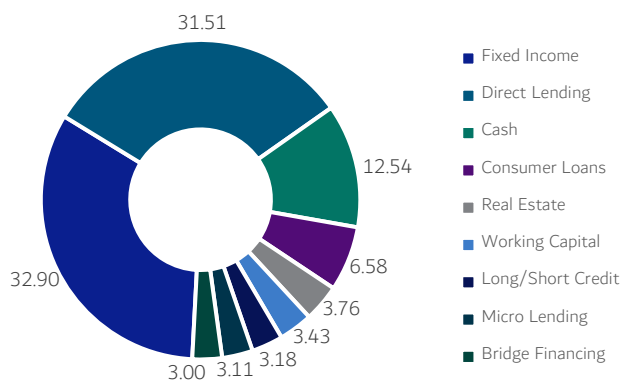
ADITUM ALTERNATIVE INCOME FUND COMMENTARY

YTD 2024 markets have been quite intriguing with bullish steepening in the US curve along with equity markets, providing phenomenal performance. The month of September presented some worrisome labour data with JOLTs and nonfarm payrolls showing stressed data which eventually led to a rate cut by the FED by 0.50%. Reported Core CPI came in 0.1% higher than expected, raising questions around the FED's path going forward.

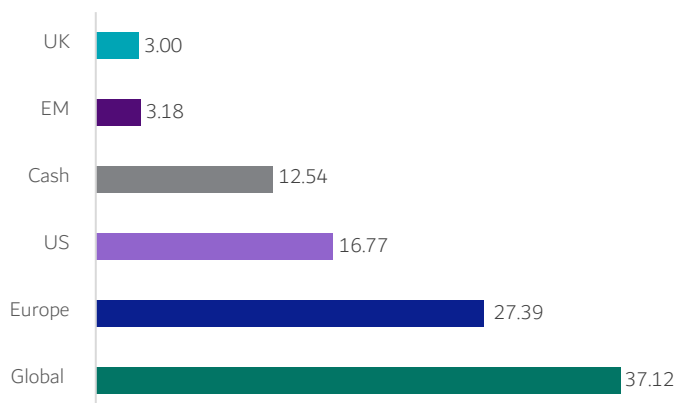
During the month, we saw a continuation of the bullish steepening and positive returns across equity markets. Oil prices remained quite volatile with Brent down by 8.9%. Moreover, the questions around global geopolitical tensions and US elections are still major factors that have not yet directly had any implication on the markets.

In terms of performance, the Fund delivered a positive return of 0.76% this month. The top performers were Man GLG Dynamic Fund which had a total return of 1.92% and Lend Invest with a total return of 1.38%. Other top performing holdings include the Global Alpha Fund, where we continue to reap the benefits of the long duration positioning of the Fund. We continue to favour long/short credit strategies and investment grade private credit strategies with locked-in yields. We continue to look for attractive opportunities to enhance our expected yields.
