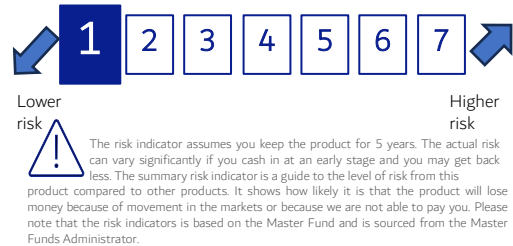

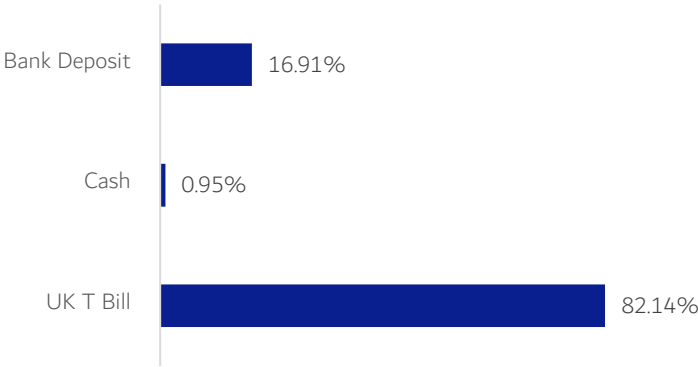

The Fund will invest in high quality, short-term fixed income securities and money market instruments, including government, quasi government and corporates issued primarily denominated in GBP or hedged back to GBP, including but not limited to bank certificate of deposits, commercial paper, corporate and sovereign variable and fixed rate bonds and floating rate notes.
