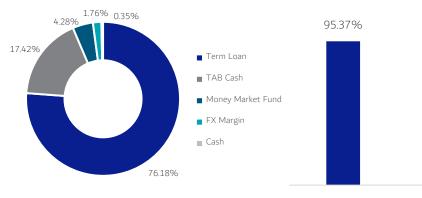

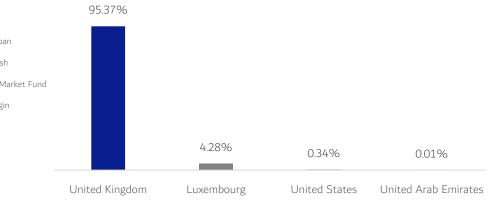

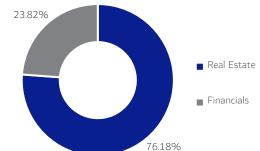


INVESTMENT BY ULTIMATE GEOGRAPHIC RISK LOCATION:

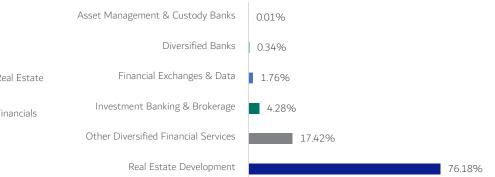


Focus Structured Loan Fund SPC SP1
