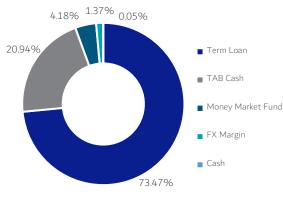

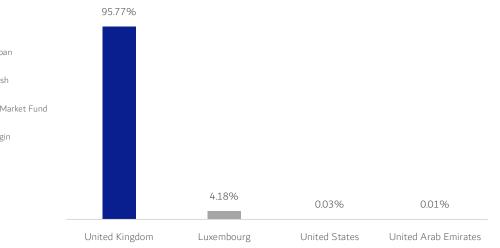

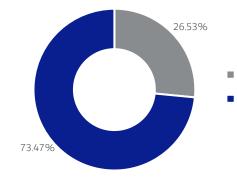


INVESTMENT BY ULTIMATE GEOGRAPHIC RISK LOCATION:

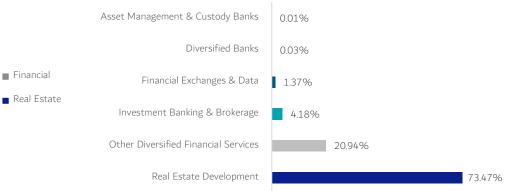
