INVESTMENT OBJECTIVE

The Signature CIO Conservative Fund Open Ended IC PLC (the “Fund” or “Conservative Fund”) is a feeder fund that seeks to achieve moderate capital growth through asset appreciation and income accumulation over a mid to long-term investment horizon. The Fund will invest in the Amundi Asia Funds - Signature CIO Conservative Fund (the “Master Fund”) which is managed by Amundi Asset Management. The Master Fund combines top-down macroeconomic views and bottom-up mutual funds and ETF selection from Standard Chartered’s Chief Investment Officer (“CIO”) and Investment Management Teams.

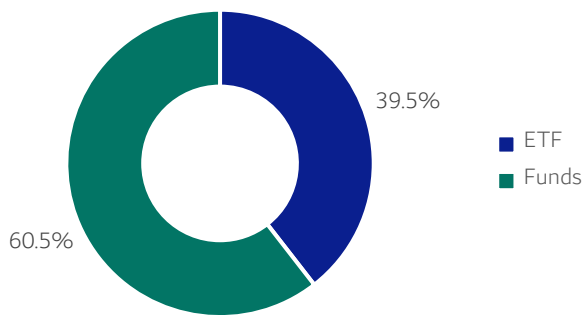

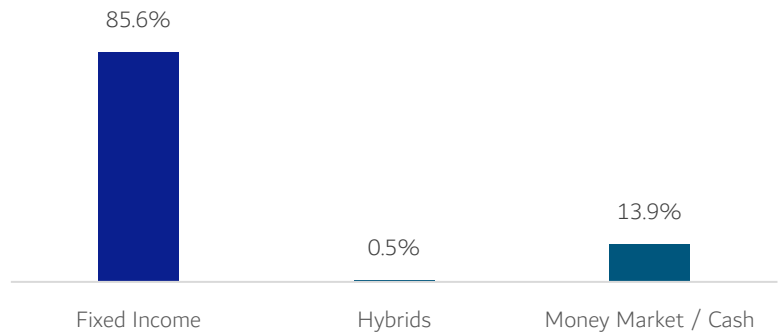

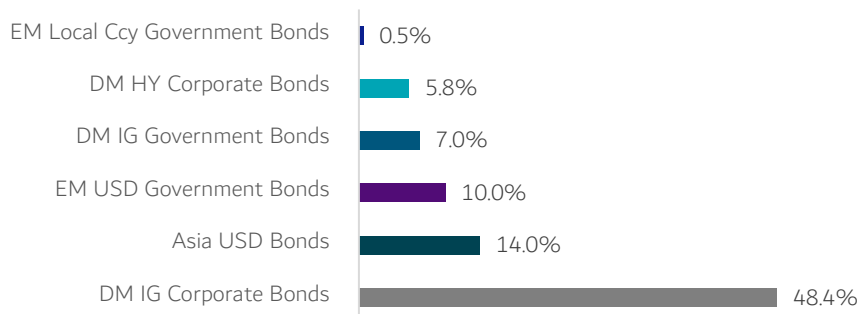
ASSET ALLOCATION*

MASTER FUND COMMENTARY

Fund Performance

The Signature CIO Conservative Fund returned flat in March. The portfolio's cautious positioning proved beneficial this month amid heightened market volatility.

Our increased allocation to floating rate notes (FRNs) added value, as the Federal Reserve held the Fed Funds rate steady during its March meeting, providing a stable environment for the asset class. Due to their adjustable coupon rates, FRNs tend to have lower price volatility than fixed rate bonds during periods of high market volatility. Additionally, incrementally reallocating to high quality assets with the same credit sleeve such as trimming US short duration high yield bonds and reallocating to sub-financials and trimming EM debt to fund a new positioning in EM USD short duration government bonds has added positively to performance. Security selection within Asia USD bonds was another positive contributor.

However, our allocation to DM HY bonds detracted from performance. The asset class struggled amid elevated interest rates and wider spreads, as investor sentiment weakened in response to ongoing geopolitical and trade policy uncertainties. Despite a modest widening in yield premiums, returns remained pressured. Additionally, EM LCY government bonds detracted due to a weaker dollar amid ongoing tariff uncertainties and waning consumer confidence.

Fund Positioning

Our portfolio remains well-positioned for the current market environment. With the objective of generating a consistent and sustainable income stream, the Signature CIO Conservative fund continues to be positioned as a high-quality portfolio of short duration fixed income, cash, and money market funds.
